All Ages Music Portland:

Thank you for choosing Office Administration Services to assist with the 2021 taxes for All Ages Music Portland. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

If management has not selected to e-file the returns with our office, management will be solely responsible to file the returns with the appropriate taxing authorities. Our engagement to prepare the 2021 tax returns will conclude with the delivery of the completed returns to management, or with e-filed returns, with the tax matters representative's signature and our subsequent submittal of the tax return.

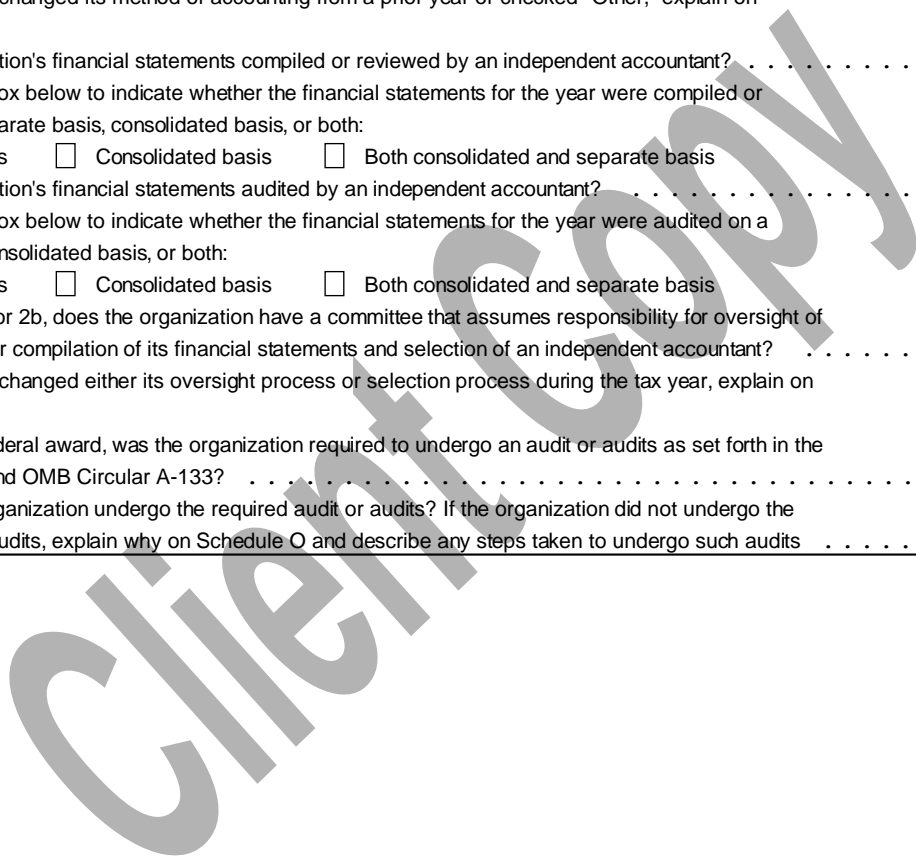
